- Provide the District a stamped "Memorandum of Understanding" and "Proof of Payment of the 2. Capital Construction Charge" from Calleguas Municipal Water District, 2100 Olsen Road, Thousand Oaks, CA 91360, Phone (805) 526-9323.
- Submit three sets of site plans or drawings that show the service line, size of meter and meter box. 3.
- Upon approval of the site plans or drawings, the District shall determine and collect fees based on 4. applicable items listed below. Make checks payable to: W & S Department.

a)	Capital Improvement Charge	\$2,000(3/4" meter) / \$4,000 (1" meter)
b)	Meter Charge	\$360(3/4" meter) / \$395 (1" meter)
c)	Water Trust Deposit	\$25(3/4" meter) / \$50 (1" meter)
ď)	Water Will-Serve Letter*	\$40
e)	Water Availability Letter*	\$40
f)	Fire Flow Test**	\$80
g)	Construction Permit	\$60
h)	Construction Inspection	\$125

- Availability and Will-Serve Letters shall be processed within 4 working days from the date fees were collected.
- Submit to the District the original of "Requirements for Construction" form 126 ** from the Fire Protection District.
- Hire a contractor, licensed by the State of California, to install the new service line. Contractor 5. shall complete and submit a construction permit application, along with a copy of liability insurance certificate that provides coverage for the District. Contractor shall obtain and submit encroachment permits from applicable agencies. Upon approval of the construction permit, Contractor may schedule a preconstruction meeting to be held at the District conference room at least two working days prior to start of construction.
- After the project is completed, customer shall complete and sign an application card for water 6. service and pay a water trust deposit as indicated above.
